You mentioned that you guys sent me through an SMS message reminder for the appointment today? It's in your notifications. So that's an automated message that's actually sent from the Workforce Australia computer system. So you're saying an SMS was sent? Yes, I am.

And that was sent yesterday? Can you put your camera back in your bag, please? I have a right to hold the camera. No, you can put it back in your bag because you're holding it and recording me at the same time and I do not consent to being recorded in this office. It's on.

Out you get. I'm not doing this. Out.

Get out of my office, please, Costa. Okay. You're not welcome in here anymore with that equipment.

Leave. This is just for cameras. I'm asking you to please leave my office.

This is my space and I'm asking you to leave. But that appointment was scheduled for 30 minutes. And we've ended it because you don't want to participate in this appointment anymore because you've advised me that I do not have your best interest at heart.

And I've actually asked you now to get out of my office. I'll give you 30 seconds. If you're not out of this office in 30 seconds, the police are going to be called.

I'm calling the police. Get out of my office. The camera's off.

Get out of my office. Please don't raise your voice. Then get out of my office.

I have asked you now three times to leave. Please don't raise your voice. This appointment was scheduled for 30 minutes.

And I've asked you a question in regards to the SSC... Leave. I am not bound to answer your questions. Get out of my office.

Now. Or do you find intimidating a woman to be something that you're actually... that this is going to be one of the new repertoire, is it? Am I intimidating you by asking you a question? I have asked you to leave and you are not leaving my space. This appointment was scheduled for 30 minutes.

I don't care how long it was scheduled for. Get out. You have to... Get out.

Don't you have a job to do? I mean, I'm just asking a question when the SMS was sent. Get out. Now.

Please don't throw things at me. I have asked you to leave. This appointment was scheduled for 30 minutes.

Oscar, get out of my office. Am I not allowed to ask questions? Yes, please. Can you please call the police and ask them to come down to... 50 more of us here because we have a sister who refuses to leave the office.

The only thing is... Actually, no. You don't need to call them. Get out.

Get out of my office. Now. What are you holding? The duress alone.

For the police. Okay. So we are going to wait for them to get here, are we? Yes, I have got an appointment.

It's 30 minutes. Get out of my office. What are you actually going to achieve by doing this? You called me.

You have asked me to come here. I didn't come here. Am I not going to go? You refuse to participate.

Alright, we are going to do this now. You refuse to participate in the office. You have then pulled out camera equipment and you are recording me and I have asked you to leave.

The camera has no... I asked you to leave and you didn't. What are you so scared of? Why are you so scared? I am not scared of anything. I just don't want you in my face.

But you have called me to come here and the appointment is 30 minutes. Because you have requirements for Centrelink. And you have requirements for Centrelink too, which is answering my questions.

I do not have to answer every single one of your questions if I do not feel that I am obligated to do so. So you feel that me asking you that if an SMS message was really sent yesterday, which by the way when you called me at 9am you said that you would be setting the appointment to... you would be setting me as a satisfactory reason not given for the appointment because you said the SMS message was sent. We are not discussing human beings, do you know that? There is no need for personal attacks.

Obviously pressing it. Pressing it, pressing it, pressing it. No, we are done.

I have advised you that we are done. And you are still in here being an absolute pig. He refuses to leave my office.

He is recording in here as well at the moment with the camera and a big thing on a microphone as well. Saying that he is not recording, however he is recording. He refuses to leave my office

and he will not get out of my space.

So you need to do something Ian. I have. Alright.

Done. I am calling them because I am just done with this guy. Now he is trying to intimidate me, which is just gross.

And he is pointing at the camera the whole time that I am on the phone talking to you. Point away. Please provide me CCTV footage of this situation.
